Craft Vendor Fee is \$35.00 per 15 x 15 space

Set up will be Saturday morning beginning at 6:00 a.m. and you must be fully set up by 9:00 a.m. Vehicles must be unloaded at your assigned space, moved to approved parking, then you may set up your booth. Booths may not be broken down before 4:00 p.m.

All goods must be handcrafted and may not be items that have been purchased for resale. Items not following this criteria, items of poor taste, or questionable items may be removed at the discretion of the committee with no refund offered.

No drugs or alcohol are allowed.

Spaces will be 15 x 15 and vendors are required to remain within this boundary. If you require more space you may purchase another 15 x 15 space. Vendors are expected to keep their area clean and safe during the festival and upon breakdown.

We do not furnish tents, tables, cords, covers, etc.. Vendors are responsible for their own equipment. If you require electricity you must request it. We have very limited spaces with electric access. **Power generators must be approved by the committee.**

We limit the number of booths and types of goods that will be sold. Our goal is to provide the public with great handcrafted items, so there will be limits on how many vendors will sell similar products.

The earlier you register the better. Someone from the Main Street Committee will call you before spaces are assigned and we will hear any special requests at that time.

Payment and self addressed stamped envelope must accompany your application. **Payable to City of Oxford**
Receipt and space assignment will be mailed to you. All applicable taxes are the responsibility of the vendor.

There will be no rescheduling of the festival in case of rain out.
Registration fee is nonrefundable
