

ORDINANCE NUMBER 2019-36

An Ordinance to Amend the Zoning Laws of the City of Oxford, Alabama, a Municipal Corporation.

BE IT ORDAINED by the City Council of the City of Oxford, Alabama, as follows:

Section 1. The following described real estate lying and being in the City of Oxford, Alabama, shall be rezoned from General Manufacturing District (M-2) to General Business District (GB).

That certain tract of land in the city of Oxford, Alabama, in the SW ¼ of the SW ¼ of Section 21, Township 16S, Range 8 East and also being a part of Block 6 of the Hillyer Robinson Industrial Park as recorded in Plat Book T, Page 37, in the Probate Office of Calhoun County, Alabama, and being bounded on the east by the Hillyer Robinson Industrial Parkway and on the south by Butler Street and being more particularly described as follows:

Beginning at a point on the north side of Butler Street, said point being 359 feet east of the west line of Section 21; thence north 89 degrees 1 minute east along the north side of Butler Street a distance of 230 feet; thence north 44 degrees 1 minute east with the west boundary of the Hillyer Robinson Industrial Parkway a distance of 99 feet; thence continue with the said west boundary north 10 degrees 41 minutes west a distance of 207.8 feet; thence south 89 degrees 1 minute west a distance of 265 feet; thence south 0 degrees 59 minutes east a distance of 275 feet to the point of beginning. Reserved from the above parcel for the use of others is a small parcel of land 25 feet x 25 feet on Butler Street which contains a cased well as recorded in Book 1410, Page 299.




