PROPOSED ORDINANCE NUMBER 2018-

An Ordinance to Amend the Zoning Laws of the City of Oxford, Alabama, a Municipal Corporation.

BE IT ORDAINED by the City Council of the City of Oxford, Alabama, as follows:

Section 1. The following described real estate lying and being in the City of Oxford, Alabama, shall be rezoned from General Manufacturing District (GM) to Residential 1 District (R-1).

Lot 1, in Block 2, according to the Plat or map of the Howle Subdivision as recorded in Plat Book K, at Page 9, Probate Office, Calhoun County, Alabama. (716 Locke Drive)

Lot 2, in Block 2, according to the Plat or map of the Howle Subdivision as recorded in Plat Book K, at Page 9, Probate Office, Calhoun County, Alabama. (712 Locke Drive)

Lot 3, in Block 2, according to the Plat or map of the Howle Subdivision as recorded in Plat Book K, at Page 9, Probate Office, Calhoun County, Alabama. (708 Locke Drive)

Lot 4, in Block 2, according to the Plat or map of the Howle Subdivision in the SE ¼ of Section 25, Township 16 South, Range 7 East, Calhoun County, Alabama, and as recorded in Plat Book K, at Page 9, Probate Office, Calhoun County, Alabama. (704 Locke Drive)
