The motion was seconded by Council Member Hubbard; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried and the Consent Agenda, Resolution Numbers 2020-49 through 2020-50, were approved.

Council President Spurlin stated he appreciated the efforts made by the Oxford School System to have graduation services for the students.

Mayor Craft stated that all the tennis courts had been resurfaced. He stated they were working with Kevin Greene for a date for the splash park to reopen.
